ORDINANCE OF THE CITY OF FARRELL, MERCER  
COUNTY, PENNSYLVANIA PROHIBITING THE  
SWEEPING, BLOWING OR DUMPING OF GRASS  
CLIPPINGS INTO STREETS.

WHEREAS, in an effort to prevent clogging of the City's storm sewer system and to maintain the City's streets generally, the City of Farrell hereby ordains as follows:

- SECTION I. That the owners and occupants of all properties in the City are hereby prohibited from sweeping, blowing or dumping grass clippings by any means or for any purpose into the streets of the City.
- SECTION II. Any person violating Section I of this ordinance shall be guilty of a summary offense and upon conviction thereof shall be fined \$25 and costs.
- SECTION III. This ordinance shall become effective after final passage and publication in accordance with the Home Rule Charter of the City of Farrell and other applicable laws.

Ordained and enacted into law on second and final reading by Council of the City of Farrell this 21<sup>st</sup> day of July, 1993.

Ordinance No. 0-1-2008

AN ORDINANCE OF THE CITY OF FARRELL, MERCER COUNTY, PENNSYLVANIA, AMENDING SECTION 1 OF ORDINANCE NO. 0-7-1993 PROHIBITING THE SWEEPING, BLOWING OR DUMPING OF GRASS CLIPPINGS, FOLIAGE OR LEAFAGE INTO CITY STREETS.

NOW, THEREFORE, be it ORDAINED AND ENACTED by Council of the City of Farrell, Mercer County, Pennsylvania and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same as follows:

Section I:

AMENDMENT: Section I of Ordinance No. 07-1993 is hereby amended and shall read as follows:

Section I. that the owners and occupants of all properties in the City are hereby prohibited from sweeping, blowing or dumping grass clippings, foliage or leafage by any means or for any purpose into the streets of the City.

Section II:

All Ordinances or parts of Ordinances in so far as they are inconsistent herewith be and the same are hereby repealed.

Section III:

The provisions of this Ordinance shall be severable and if any of the provisions hereof shall be held unconstitutional, void or otherwise unenforceable such shall not affect the validity of any remaining provisions of said Ordinance.

Section IV:

This Ordinance shall become effective immediately upon passage and publication thereof, in accordance with the Home Rule Charter of the City of Farrell and existing law.
